Concept mapping (CM) is a dynamic and rigorous process that can engage community partners in elaborating ideas and developing a shared understanding of relationships between those ideas^[1]. CM participants engage in brainstorming responses to a focal question, later sorting and rating those items across several continuums. The data is then analyzed using quantitative techniques, leading to the production of graphic representations that illustrate the relative importance of each concept and the relationships between them. In the final stage, these graphic representations (the “concept maps”) are presented to participants, who engage with the research team to interpret and refine these ideas and relationships; they discuss the impact they have on the community and how they inform future action steps. Through this workshop, we will collaboratively explore our collective perception of the pathways through which work influences health and well-being in precarious and underserved workers.
